AMENDMENT AGREEMENT



ACME CLEANTECH SOLUTIONS PRIVATE LIMITED, a company duly incorporated under the laws of India (CIN: U74110HR2003PTC035026), having its registered office at Plot No. 152, Sector-44, Gurugram-122002, Haryana, India (referred to as the "ACME Cleantech", which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns);

AND

ACME SOLAR HOLDINGS LIMITED, a company duly incorporated under the laws of India (CIN: U40106HR2015PLC102129), having its registered office at Plot No. 152, Sector-44, Gurugram-122002, Haryana, India (referred to as the "**ACME Solar**", which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns).

ACME Cleantech and ACME Solar are hereinafter individually referred to as "Party" and collectively referred to as the "Parties".

WHEREAS

- 1. ACME Cleantech and ACME Solar had entered into an Agreement for Transfer of Employees dated June 25, 2024 ("Agreement") in terms of which ACME Cleantech had agreed to transfer certain Identified Employees (as defined under the Agreement) of ACME Cleantech to ACME Solar with effect from the Transfer Date (as defined under the Agreement).
- 2. Now, pursuant to the revised understanding between the Parties, the Parties have agreed to amend the Agreement to the extent as set out under this Amendment Agreement.

NOW, THEREFORE, in consideration of the mutual agreements and covenants herein contained and as contained under the Agreement, the Parties agree to amend the Agreement as follows:

- 1. The definition of "Transfer Date" appearing in Clause 1 of the Agreement shall be deleted in its entirety and replaced with the following:
 - ""Transfer Date" shall mean 1 November 2024, i.e. the date on which the Identified Employees shall be transferred to ACME Solar in accordance with the terms of this Agreement."
- 2. The Parties mutually covenant and agree to replace Schedule A (List of Identified Employees) of the Agreement with Annexure 1 enclosed herewith. Upon execution of this Amendment Agreement, Annexure 1 shall be deemed to be the new Schedule A for purposes of the Agreement.

3. Miscellaneous

3.1 Any reference to the Agreement shall include a reference to the Agreement as amended by this Amendment Agreement. The Agreement, along with this Amendment Agreement, shall be read and construed as one document.

- 3.2 Capitalized terms used but not defined in this Amendment Agreement shall have the meanings ascribed thereto in the Agreement.
- 3.3 The Parties agree that this Amendment Agreement shall come into force with effect from the Execution Date. In the event of any contradiction or inconsistency between the Agreement and this Amendment Agreement, the provisions of and understanding set out in this Amendment Agreement shall prevail, to the extent of any inconsistency or contradiction.
- 3.4 Except as expressly modified by this Amendment Agreement, all other terms and conditions of the Agreement shall remain unchanged and shall remain in full force and effect.
- 3.5 The provisions related to governing law of the Agreement and dispute resolution shall apply *mutatis mutandis* to this Amendment Agreement.
- 3.6 This Amendment Agreement may be executed in any number of counterparts, each of which shall be considered an original, but all of which together shall constitute one and the same Amendment Agreement.
