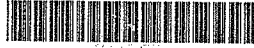

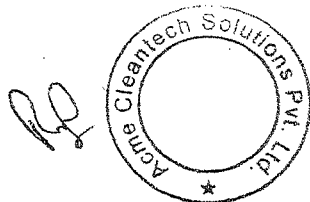

Ltd., an Indian company, having its office at Plot no. 152, Sector-44, Gurgaon – 122002, (Haryana), India, herein referred to as "ASSIGNEE 1" (which expression shall unless repugnant to the context or meaning thereof be deemed to mean and include the successors, executors and assigns of the assignor) OF THE OTHER PART.

AND

ACME Solar Energy Pvt. Ltd., an Indian company, having its office at Plot no. 152, Sector-44, Gurgaon – 122002, (Haryana), India, herein referred to as "ASSIGNEE 2" (which expression



shall unless repugnant to the context or meaning thereof be deemed to mean and include the successors, executors and assigns of the assignor) **OF THE OTHER PART.**

Whereas the Assignee 1 and Assignee 2 are collectively referred to as the Assignees.

Whereas, the Assignor is the lawful owner of the registered trademarks, disclosed in **Annexure - A** (hereinafter referred to as "**Trade Marks**") and has earned goodwill in the market.

Whereas, the Assignor holds sole and absolute right, title, ownership and interest along with the goodwill, in all the Trade Marks.

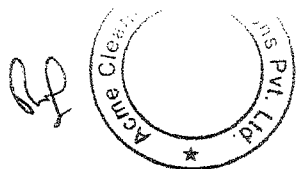
Whereas, the Assignor desires to assign, the rights, title, ownership and interest derived from and in connection with the Trade Marks along with the goodwill in the Trade Marks, to the Assignees.

Whereas, the Assignees desire to acquire, the rights, title and interest derived from and in connection with the Trade Marks along with the goodwill in the Trade Marks, from the Assignor.

Whereas, the Assignees are the subsidiaries of the Assignor.

NOW, THEREFORE, the Parties witness as follows;



1. That the Assignor, for a consideration of Rs 1,000 each, the sufficiency and receipt of which is mutually acknowledged by the parties, agrees to assign rights, title to use and other interest along with the goodwill, in all the Trade Marks, to the Assignees, worldwide.
2. That the Assignees acknowledge acquiring the rights, title to use and other interest along with the goodwill, in the Trade Marks, from the Assignor, worldwide.
3. That the Assignor undertakes to do all acts that may be necessary or desirable to permit and assist the Assignees in obtaining, perfecting and enforcing the full benefits, enjoyment, rights and title along with the goodwill, in the Trade Marks, throughout the world.
4. That the Assignor hereby irrevocably designate and appoint the Assignees, its authorized officers, agents and/or attorneys to act for and on behalf of the Assignee to take all lawfully permitted acts to further the filing, prosecution, registration, memorialization of assignment, issuance and enforcement of the Trade Marks, whether by way of registration or otherwise, all with the same legal force and effect as if done in person by the Assignor.

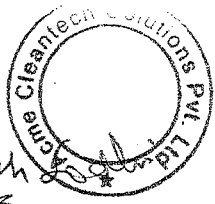


5. That the Assignor hereby waives and agrees not to initiate any action/legal proceeding against the Assignees for any infringement/misappropriation by the Assignees of the Trade Marks prior to the Effective Date.
6. That the Assignor hereby authorize the Assignees to use the Trade Marks for themselves and for their present and future subsidiaries.
7. This Assignment Deed is the entire agreement concerning the subject matter hereof. It supersedes all prior and contemporaneous agreements, assurances, representations, and communications between the parties.


