(the "ACME CLEANTECH")

AND

ACME SOLAR HOLDINGS LIMITED

(the "ACME SOLAR")

AND

**THE PARTIES WHOSE NAMES AND ADDRESSES ARE SET OUT IN SCHEDULE A
HERETO**

DEED OF NOVATION

This deed of novation ("Deed") is made at Gurugram, Haryana on 25th day of June, 2024 ("Effective Date"):

BY AND BETWEEN:

- 1) **ACME Cleantech Solutions Private Limited**, a company incorporated under the laws of India, bearing corporate identification number U74110HR2003PTC035026, and having its registered office at Plot No. 152, Sector 44, Gurugram, Haryana - 122 001, India (hereinafter referred to as "**ACME Cleantech**", which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns) of the **FIRST PART**;

AND

- 2) **ACME Solar Holdings Limited**, a company incorporated under the laws of India, bearing corporate identification number U40106HR2015PLC055641, and having its registered office at Plot No. 152, Sector 44, Gurugram, Haryana - 122 001, India (hereinafter referred to as "**ACME Solar**", which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns) of the **SECOND PART**;

AND

- 3) **The Parties whose names and registered office address are set out in Schedule A**, severally and not jointly, (hereinafter each referred to as the "**Company**" and collectively as the "**Companies**", which expression shall, unless repugnant to the context or meaning thereof, be deemed to mean and include its successors and permitted assigns) of the **THIRD PART**.

ACME Cleantech, ACME Solar and the Companies are hereinafter collectively referred to as "**Parties**" and individually as a "**Party**".

WHEREAS:

- A. The Companies are engaged in the business of holding, developing, and operating solar photovoltaic power project(s), the details of which are more particularly described in **Part A of Schedule B ("Project")**.
- B. ACME Cleantech and each of the Company had entered into an operation and maintenance agreement, the details of which are more particularly described in **Part B of Schedule B (as amended and supplemented from time to time) ("O&M Agreement(s)")**, in terms of which ACME Cleantech had undertaken to provide certain operations and management related services to the respective Companies in respect of their Projects.
- C. Pursuant to mutual discussions between the Parties and as part of certain internal restructuring contemplated within the ACME group, it is intended that all operations and maintenance related activities and operations shall be housed within ACME Solar and its subsidiaries. Accordingly, ACME Cleantech has agreed to novate all of its rights, obligation, interests and title under the O&M Agreements to ACME Solar through this Deed.
- D. In light of the aforementioned understanding, the Parties now wish to record in this Deed, the terms and conditions of the proposed novation of the O&M Agreements by ACME Cleantech of

all its rights, obligations, interests and title thereunder, to ACME Solar in accordance with the terms of this Deed.

NOW THEREFORE, in consideration of, and subject to, the mutual covenants, agreements, terms and conditions herein contained the mutual benefits to be derived there from and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties intending to be legally bound, hereby agree as follows:

1. INTERPRETATION

- 1.1 All capitalized terms used in this Deed, unless specifically defined herein, shall have the same definition and meaning as assigned to them in the respective O&M Agreements.
- 1.2 Unless the context of this Deed otherwise requires:
- (a) words importing the singular include the plural and vice versa;
 - (b) reference to the words "include" or "including" shall be construed without limitation;
 - (c) reference to a gender includes reference to the other gender;
 - (d) reference to this Deed or any other agreement, deed or other instrument or document shall be construed as a reference to the Deed, such agreement, deed or other instrument or document as the same may from time to time be amended, varied, supplemented or novated;
 - (e) any reference to time shall, except where the context otherwise requires, be construed as a reference to the time in India. Any reference to a year shall be construed as a reference to the calendar year, unless specified otherwise. Any reference to the calendar shall be construed as reference to the Gregorian calendar;
 - (f) reference to any applicable law shall be deemed to include a reference to such applicable law as is re-enacted, modified or amended from time to time;
 - (g) the headings in this Deed are for reference only and shall not affect the interpretation or construction hereof; and
 - (h) references to Recitals, Clauses or Schedules are, unless the context requires otherwise, references to Recitals, Clauses of, or Schedules to this Deed, which shall be deemed to constitute an integral part of this Deed.

2. EFFECTIVENESS

This Deed shall be effective on and from the Effective Date (i.e., the date of execution of this Deed).

3. NOVATION OF THE O&M AGREEMENT

- 3.1 Each of the Parties covenant, undertake and agree, that ACME Solar shall, with effect from the Effective Date, become a party to the O&M Agreements in place of ACME Cleantech. Further,



on and from the Effective Date, all references to "Operator" in each of the O&M Agreements shall be construed and deemed to be a reference to ACME Solar (in place of ACME Cleantech).

1.2 ACME Cleantech hereby novates all its rights, title, obligations, interests, and liabilities under, pursuant to and arising out of each of the O&M Agreements in respect of the respective Project in favor of ACME Solar and ACME Solar hereby accepts, assumes, takes over and succeeds to all of ACME Cleantech's rights, title, obligations, interests and liabilities under, pursuant to and arising out of each of the O&M Agreements.

1.3 Pursuant to such novation, the Parties agree that with effect from the Effective Date:

(a) The Company and ACME Cleantech are each released and discharged from [their obligations to each other with respect to each of the O&M Agreements and their respective rights against each other thereunder are cancelled, *provided that* such release and discharge shall not affect any rights, liabilities or obligations of the Company or ACME Cleantech with respect to any obligation or liability that may have accrued under any of the O&M Agreements prior to the Effective Date;

(b) ACME Solar shall be bound by and shall discharge, perform, and comply with all the terms, conditions, provisions, obligations, covenants and duties of ACME Cleantech in connection with all and any of ACME Cleantech's rights and obligations under, pursuant to and arising out of each of the O&M Agreements, as if ACME Solar were an original party thereto (in place of ACME Cleantech);

(c) The Company shall deal directly and only with ACME Solar in respect of exercising any rights or enforcing any obligations arising out of the O&M Agreements, in respect of ACME Solar's performance or failure to perform any obligations under the O&M Agreements; and

(d) ACME Cleantech shall not be liable for any claims raised by the Company for any non-compliance of the terms and conditions of any of the O&M Agreements by ACME Solar.

1.4 Notwithstanding anything contained in this Deal, the Parties hereby expressly agree and acknowledge that under no circumstances shall ACME Solar be held responsible and/or liable for any direct or indirect losses suffered by the Company either prior to the Effective Date or post the Effective Date, which consists from any breach, default or negligence attributable to ACME Cleantech in relation to any event occurring prior to the Effective Date.

1.5 To give effect to the novation contemplated in this Clause 1 above, the Parties hereby agree and acknowledge that on or prior to February 1, 2023 or such other date as may be mutually agreed between ACME Cleantech and ACME Solar (in writing) ("Transfer I.S. Date");

1.5.1 ACME Cleantech shall deliver and transfer, all of the spares and inventory items available with ACME Cleantech in respect of the Projects ("**Spares and Inventory Items**") to ACME Solar, which items will be specifically identified in the delivery note to be issued by ACME Cleantech, and such delivery note shall be acknowledged and executed by ACME Solar at the time of delivery and transfer of such Spares and Inventory Items. As consideration for such transfer of the Spares and Inventory Items, ACME Solar shall pay to ACME Cleantech an (all inclusive) amount which is equivalent to the aggregate of the book value of the Spares and Inventory Items being delivered and transferred by ACME Cleantech, which amount shall be mutually agreed (in writing) between ACME Cleantech and ACME Solar prior to such transfer.

3.5.2 All of the sub-contracts and purchase orders entered into by ACME Cleantech pursuant to the O&M Agreements as set-out and identified in **Schedule C (List of Sub-Contracts)** which are subsisting, and such other sub-contracts and purchase orders entered into by ACME Cleantech pursuant to the O&M Agreements prior to the Effective Date, as may be mutually agreed between ACME Cleantech and ACME Solar (in writing) (hereinafter collectively referred to as "Sub-Contracts") shall be novated in favour of ACME Solar on terms no less favorable than the terms of the existing Sub-Contracts, and ACME Cleantech shall undertake all actions (as may be required) to ensure that all Sub-Contracts are novated in favour of ACME Solar (including by way of execution of separate novation contracts) with the counter-parties to each of such Sub-Contracts). The Parties hereby agree that as an alternative to the novation of the Sub-Contracts, ACME Cleantech shall terminate the relevant existing Sub-Contracts, and in such case ACME Solar may enter into separate sub-contracts (on terms no less favorable than the terms of the existing Sub-Contracts or on such other terms as may be agreed by ACME Solar with the relevant counterparty(ies)) with the relevant counter-party(ies) of the Sub-Contracts which have been terminated by ACME Cleantech.

3.6 The Parties hereby agree that during the period on and from the Effective Date up to and including the Transfer LS Date ("**Identified Period**"):

3.6.1 ACME Cleantech shall provide access, deliver and/or make available to ACME Solar all of the Spares and Inventory Items, promptly upon any request from ACME Solar to such effect, on a free of charge basis;

3.6.2 Unless and until the Spares and Inventory Items have been delivered and transferred to ACME Solar, ACME Cleantech shall hold such Spares and Inventory Items in trust for the benefit of ACME Solar, and ACME Cleantech shall provide ACME Solar access to all relevant books, documents and other information available or maintained in relation to the Spares and Inventory Items as ACME Solar may require from time to time; and

3.6.3 Unless and until the Sub-Contracts have been novated in favour of ACME Solar or the Sub-Contracts have been terminated by ACME Cleantech in accordance with Clause 3.5.2 above, ACME Cleantech shall discharge its obligations and/or exercise its rights under the Sub-Contracts in accordance with the instructions received from ACME Solar. Provided that all expenses incurred by ACME Cleantech in respect of the same shall be borne and payable by ACME Solar.

4. SUPPLEMENTAL UNDERSTANDING

4.1 The Parties hereby expressly agree and acknowledge that all operations and maintenance related agreement(s) in respect of all projects which are contemplated to be developed and constructed by any subsidiary of ACME Solar, shall on and from the Effective Date, be awarded solely to ACME Solar or any of its subsidiary (to the exclusion of ACME Cleantech).

5. REPRESENTATIONS AND WARRANTIES

Each Party represents and warrants to the other Parties that:

(a) In entering into this Deed, it is acting in its own capacity and not in the capacity as trustee of any trust or as agent on behalf of any entity;



- (b) It has the full power and authority to execute, deliver and perform this Deed and to carry out the transactions contemplated hereby;
- (c) To the best of its knowledge, the execution, delivery and performance by it of this Deed, does not and will not materially conflict with any of its legal, contractual, or organizational requirements; and
- (d) Its obligations under this Deed are valid and binding and are enforceable against it in accordance with the terms of this Deed.

6. MISCELLANEOUS

- 6.1 If there is any inconsistency between the terms and provisions of this Deed and the terms and provisions of the O&M Agreement, the terms and provisions of this Deed shall prevail in respect of such inconsistency.
- 6.2 This Deed, as entered into, shall be binding upon the Parties and their respective successors and assigns.
- 6.3 The Parties shall do all such acts, deeds and things and execute all such other documents as may be required to implement the terms and conditions of this Deed.
- 6.4 This Deed sets out the entire agreement and understanding between the Parties with regard to the subject matter hereof, and supersedes all prior agreements, understandings or arrangements (whether oral or written), with respect to such subject matter in any way.
- 6.5 For the purposes of the 'Notices' provision under each of the O&M Agreements, it is hereby agreed that all such Notices shall be sent to ACME Solar (*as Operator*) to the following address:

- 6.6 The provisions of this Deed shall, in all respects, be governed by and construed in accordance with the laws of India. The courts at Gurugram, Haryana shall have the exclusive jurisdiction to settle any claim or matter arising under this Deed.
- 6.7 This Deed shall be executed simultaneously in any number of counterparts, each of which shall be deemed an original, but all of which will constitute one and the same instrument provided that this Deed shall be deemed to come into effect, upon the last of the Parties having executed this Deed. Delivery of an executed counterpart (in full) in Adobe™ Portable Document Format (PDF) sent by electronic mail shall take effect as delivery of an executed counterpart of this Deed. If this method is adopted, without prejudice to the validity of this Deed, each Party shall provide the other Parties with the original of such counterpart as soon as reasonably practicable thereafter.

6.8 Notices

Any notices, requests, demands or other communication required or permitted to be given under this Deed and the provisions contained herein shall be written in English and shall be sent by electronic mail, registered post, postage prepaid or courier to the other Party at the address indicated below:

or at such other address as the Party to whom such notices, requests, demands or other communication is to be given shall have last notified the Party giving the same in the manner provided in this Clause, but no such change of address shall be deemed to have been given until it is actually received by the Party sought to be charged with the knowledge of its contents. Any notice, request, demand or other communication delivered to the Party to whom it is addressed as provided in this Clause shall be deemed (unless there is evidence that it has been received earlier) to have been given and received, if:

- (a) sent by mail, except air mail, 10 (ten) days after posting it;
- (b) sent by air mail, 5 (five) days after posting it; and
- (c) sent by e-mail, when confirmation of its transmission has been recorded by the sender's e-mail account.
- 6.9 No delay in exercising or omission to exercise any right, power or remedy accruing to a Party upon any default under this Deed shall impair any such right, power or remedy or shall be construed to be a waiver thereof or any acquiescence in such default, nor shall the action or inaction of such Party in respect of any default or any acquiescence by it in any default, affect or

impair any right, power or remedy of such Party in respect of any other default. Any waiver can only be made by a written instrument.

- 6.10 No Party shall be entitled to assign or otherwise deal with this Deed or any right under this Deed without the prior written consent of the other Party.
- 6.11 Each Party shall pay the costs and expenses incurred by it in connection with the entering into and performance of this Deed.
- 6.12 No amendment or modification of any provision of this Deed shall be effective unless the same is in writing and has been signed by each of the Parties hereto.
